## West Creston Fire Protection Society:

"Improving your odds against a wild fire"

As of August 15<sup>th</sup>, there have been 1,421 forest fires in B.C., mainly due to lightning hitting standing dead timber caused by the Pine Beetle infestation.

Warning signs of the Pine Beetle are now showing up in West Creston. All the rust patches, along the top of Mount Creston are standing dead trees, a dangerous fire hazard for our community.

By implementing the suggested techniques in the Forest Service's, FIRESMART program which was delivered to your home the end of June, we can help to minimize our own personal losses.

Make sure your roof, gutters and collective corners have not accumulated leaves or needles. Keeping a green and mowed lawn, and not having dense brush or forest within 30 meters of your home, will help provide a good firebreak.

*New Campfire Regulations:  
(Ministry of Forests and Range)*

*Campfires must NOT be larger than 0.5 metres by 0.5 metres, or about 19 in. by 19 in.*

*You MUST have a shovel OR at least eight litres or water nearby to extinguish the fire;*

*A firebreak must surround your fire – create one by scraping down to the dirt – one metre around the fire; and*

*You MUST NEVER leave a campfire unattended.*

*Before leaving the area, always ensure your campfire is completely extinguished and ashes are cool to the touch.*
